Privacy Policy

Garden Club of Denver (GCD) respects your privacy. When you visit the GCD website at www.gardenclubofdenver.com (the Website), we may collect information about you and your visit to operate and improve the GCD website and respond to your inquiries. Please be assured, the GCD will never rent or sell *any* information that identifies you personally (personal information). This Privacy Policy applies to the Website and to all websites owned and/or controlled by GCD.

Information We Collect

When you visit the Website, our servers automatically log certain technical information, such as the date and time of your visit, the name of the website you are navigating from, the type of browser you are using, and your Internet protocol address. We also collect information about how visitors use our website. This information does not identify you personally.

How We Use and Share that Information

We use information about you and your visit to operate and improve the GCD website and to respond to your inquiries. We will not share your personal information with third parties unless you have given us permission or it is necessary to protect the rights, property, or safety of the GCD or others, or as required by law.

Cookies

To operate the Website, fulfill your requests, and recognize you when you return to the Website, our servers place a cookie on your computer's hard drive. A cookie is a small file containing a string of characters that is sent to your computer when you visit a website. Cookies may store user preferences and other information. You can reset your browser to refuse all cookies or to indicate when

a cookie is being sent. However, some Website features or services may not function properly without cookies.

Special Information about Photos and Postings

If you are a member of GCD, you may have the opportunity to post photographs, comments, and other content that may contain personal information in the Members Area of the Website. By submitting comments, success stories, and photographs to on the Website, you give us permission to publish this information on the Website. Please remember that by posting information or photographs on the interactive portions of our Website that you are making this information available to other GCD club members.

Emails and Newsletters

When you log on to the Members Area of the GCD Website you agree to receive emails from us, including notices about the status of your account, confirmation of email address or password changes, or customer service inquiries regarding activity on your account. In addition, we may send you emails containing information that we think may be of interest to you, including information about new tools that are available on the site, You can choose not to receive promotional emails by contacting us at gardenclubofdenver@gmail.com. Your opt-out will not apply to communications that are directly related to a specific communication by you with GCD.
